I. Storage of personal data of customers and suppliers:

The protection of personal data is a special concern of MedRes Kft. We process personal data exclusively on the basis of the statutory provisions (in particular in accordance with the **General Data Protection Regulation / GDPR**).

Name, address, telephone number, e-mail address, department and function, place of birth, date of birth, mother's name, address, and other natural identifiers of the representative.

We have received these data either from you, your company or from public sources such as company register, your website, telephone book, tender etc.

The lawfulness of the processing of your data is based on the following:

- **European Parliament and Council (EU) 2016/679 Decree (general data protection decree; known as GDPR).**

Please note that all employees of our company who take care of our customers and/or suppliers have access to these data, and if required, your name, address, telephone number will be provided to the transport company/shipping company agreed and commissioned with the delivery of the goods.

II. Cookies

Our website can use "cookies". These are small text files that are stored on your device using the browser. They're not doing any damage.

We use cookies to make our website user-friendly. Some cookies remain stored on your device until you delete them. They enable us to recognize your browser the next time you visit us.

If you do not want that we use these cookies, you can set your browser so that it informs you about the use of cookies and you can confirm on a case-by-case basis.

When cookies are deactivated, the functionality of our website may be limited.

III. General rights of persons affected

You have the rights of access (Art 15 GDPR), rectification (Art 16 GDPR), deletion ("right to be forgotten" - Art 17 GDPR), restriction of processing (Art 18 GDPR), data transferability (Art 20 GDPR), revocation of your consent (Art 7 (2) GDPR) and objection (Art 21 GDPR). If you believe that the processing of your data violates data protection law or your data protection rights have otherwise been violated in any way, you can complain to the supervisory authority (right of appeal to a supervisory authority - Art 77 GDPR).
